MINUTES: Charles Davis made a motion to accept the minutes of the January 2, 2018 Reorganization Meeting and the January 8, 2018 Special Meeting. Edward Babyak seconded the motion. The motion was unanimously approved.

EXECUTIVE SESSION: Krisha DiMascio announced that prior to the meeting an Executive Session was held to discuss items related to personnel and pending litigation. She also announced that Council held Executive Sessions following the January 8, 2018 special meeting and at the February 5, 2018 Workshop meeting for the purposes of personnel and pending litigation.

Mr. Robert (Regina) Crouch, 1807 Kansas Avenue: Expressed concern about the intersection of Guice and Kansas Streets. There are cars speeding and driving through the area with stopped school buses.
