# MINUTES OF THE REGULAR MEETING OF WHITE OAK BOROUGH COUNCIL HELD MONDAY, FEBRUARY 18, 2008 AT 8:00 P.M.

#### CALL TO ORDER

Mr. Petro, President of Council, called the Regular Meeting to order at 8:00 p.m.

#### PLEDGE OF ALLEGIANCE

Mr. Petro led those attending in the Pledge of Allegiance.

#### ROLL CALL

Attending were Council members Edward Babyak, Charles Davis, George Dillinger, Ronald Massung, David Pasternak, Jack Petro, Jr. and Kenneth Robb. Also attending were Mayor Ina Jean Marton, Solicitor Terry Leckman, Engineer Representative Donald Hultberg and Borough Secretary Nancy Greenland.

#### **MINUTES**

Mr. Petro asked if there were any additions or corrections to the following Minutes:

Workshop Meeting – January 16, 2008 Workshop Meeting – January 21, 2008 Regular Meeting – January 21, 2008

There were none.

A motion was made by Mr. Babyak, seconded by Mr. Massung, to accept the Minutes as presented.

Motion carried unanimously.

#### EXECUTIVE SESSION

Mr. Leckman indicated there were a number of issues discussed during various Executive Sessions. Discussions were held on personnel matters and pending litigation.

## **PUBLIC COMMENTS**

Daryl Cassidy - 817 Vermont Avenue

Mr. Cassidy indicated a new gas line was installed along Vermont Avenue by Trafford Corp. a sub-contractor for Equitable Gas. Since the work was completed, he noted his retaining wall fell down twice. Water runoff from this work washed away the footer. The road is still closed to through traffic. He stated he felt that Equitable and Trafford should be held accountable for the problems in this area.

Mr. Robb noted he was briefed by Mr. McCabe, Public Works Supervisor, and this is a private matter between the gas company, its subcontractor and the property owners. The Borough is acting only as a middle man.

Mr. McCabe stated Trafford was to have been in last week to patch the roadway with cold patch, but due to the weather this was not done. He noted hot paving material would not be applied until spring when the asphalt plants open up. He commented the issue with the wall is between the property owner and Trafford Corp and Equitable Gas. He further noted that when the new gas line was being installed Trafford broke several sewer laterals in that area and waste water was running on the street. The Public Works Department has been applying salt. The road was closed as a safety issue so that the new line would not be crushed under the pressure of traffic. The work also caused ground/surface water to flow out onto the street and stated once the cold patch is installed the drainage issue on the road should be eliminated. He indicated he would contact Trafford tomorrow to find out when they would be laying the cold patch.

Mr. Massung asked Mr. Cassidy if he had contacted Equitable or Trafford.

Mr. Cassidy indicated he called Equitable Gas who in turn referred him to Trafford Construction. He further stated he had also referred the matter to the PUC which is investigating the problem.

Mr. Robb noted the Borough would continue to act as a middle man.

#### George Ursta - 218 Congress

Mr. Ursta stated Trafford Construction put a cap on his neighbors lateral and eliminated 60 to 70 feet of pipe. This caused sewage to back up into the neighbor's home. There was raw sewage running on the road for three (3) weeks. During the excavation, quarter size holes could be seen in the water line. He noted the Borough's Public Works Department has done an excellent job in trying to assist and eliminate some of the issues. He stated the wall that collapsed was installed 7 years ago and since the gas line was replaced the wall had to be rebuilt twice.

Mr. Babyak asked if the condition of the water line was reported to MAWC.

Mr. Ursta noted it was and there have been three (3) or four (4) breaks over the last eight (8) or nine (9) years. He further stated that when digging the trench for the new line Trafford must have broken into a water shed which created a constant flow of water.

Mr. Petro stated the Borough would do what they could to mediate the problem. He again stated this was a private matter between the property owners and the gas company and its subcontractor.

Mr. Pasternak, Chairperson, noted the Borough hosted the January COG meeting at which he was sworn in as President. He further stated a Search committee was formed to look for a new location to house the COG operations. A number of sites will be looked at in several municipalities.

Mr. Pasternak stated the Recreation Board in co-operation with the WOAA Board held a New Year's Eve Party. The event had a net profit of approximately \$3,100.00 which will be split between the two groups.

Mr. Pasternak commented Community Day has been scheduled for Saturday, July 5th.

Mr. Pasternak advised the WOAA participated in the Festival of Trees for the first time. It took first place in the inspiration division. He further noted the Board reorganized this year and President is Karen Slobodian; Vice President is Andrew Macey; Treasurer is Sylvan Lange; Kim Winters is Secretary; and Denise Haselhoff as Financial Secretary.

Mr. Pasternak advised the annual dinner meeting of COG is scheduled for March 27 at the Yough Country Club.

A motion was made by Mr. Pasternak, seconded by Mr. Robb, authorizing the proper Borough officials to receive proposals for core drilling at Heritage Hill Park and WOAA.

# Planning, Zoning and Code Enforcement Officer's Reports
